

IRS2Go is the IRS mobile app that allows you to make payments using your mobile device.

Electronic Federal Tax Payment System (EFTPS). Individual taxpayers are no longer able to create new enrollments via EFTPS.gov. Instead, they need to create an IRS Online Account for Individuals or use IRS Direct Pay.

If you are already enrolled in EFTPS.gov to make your individual tax payments, you are still able to. However, all individuals will be required to transition from EFTPS.gov later in 2026.

Underpayment of Estimated Tax

If you did not pay enough tax throughout the year, either through withholding or by making estimated tax payments, you may have to pay a penalty for underpayment of estimated tax. Generally, most taxpayers will avoid this penalty if they owe less than \$1,000 in tax after subtracting their withholdings and credits, or if they paid at least 90% of the tax for the current year, or 100% of the tax shown on the return for the prior year, whichever is smaller.

The penalty may also be waived if:

- The failure to make estimated payments was caused by a casualty, disaster, or other unusual circumstance and it would be inequitable to impose the penalty, or
- You retired (after reaching age 62) or became disabled during the tax year for which estimated payments were required to be made or in the preceding tax year, and the underpayment was due to reasonable cause and not willful neglect.

Additional Medicare Tax. A 0.9% additional Medicare tax applies to Medicare wages, Railroad Retirement Tax Act compensation, and self-employment income over the threshold amount based on your filing status. You may

need to include this amount when computing your estimated tax.

Net investment income tax (NIIT). NIIT is a 3.8% tax on the lesser of net investment income or the excess of your modified adjusted gross income (MAGI) over the threshold amount for your filing status. NIIT may need to be included when computing your estimated tax.

Estimated Taxes

The federal income tax is a pay-as-you-go tax. You must pay the tax as you earn or receive income during the year. There are two ways to pay as you go, either by withholding or making estimated tax payments.

Withholding. If you are an employee, your employer generally withholds income tax from your pay. In addition, tax may be withheld from certain other income such as IRAs, pensions, bonuses, commissions, and gambling winnings. If all of your income will be subject to income tax withholding, you probably do not need to pay estimated tax. Events during the year may change your marital status, dependents, adjustments, deductions, or credits you expect to claim on your tax return. When this happens, you should complete a new Form W-4, *Employee's Withholding Certificate*, so that the appropriate amount of tax is withheld.

Estimated tax. Estimated tax is the method used to pay tax on income that is not subject to withholding. This includes income from self-employment, interest, dividends, alimony, rents, gains from the sale of assets, prizes, and awards. You also may have to pay estimated tax if the amount of income tax being withheld from your salary, pension, or other income is not enough.

Estimated tax is used to pay not only income tax, but self-employment tax and alternative minimum tax as well. If you do not pay enough by the due date of each quarterly payment period you may be charged a penalty even if you are due a refund when you file your tax return.

Who Must Pay Estimated Tax

If you are filing as a sole proprietor, partner, S corporation shareholder, and/or a self-employed individual, you generally have to make estimated tax payments if you expect to owe tax of \$1,000 or more when you file your return.

If you owed additional tax for the prior year (did not have enough withheld by employer), you may have to pay estimated tax for the current year.

General rule. In most cases, you must pay estimated tax for the current year if both of the following apply.

- 1) You expect to owe at least \$1,000 in tax for the current year, after subtracting withholding and refundable credits, and
- 2) You expect your withholding and refundable credits to be less than the smaller of:
 - a) 90% of the tax to be shown on your current year tax return, or
 - b) 100% of the tax shown on your previous year's tax return if your previous year's return covered all 12 months. Substitute 110% for 100% if your 2025 adjusted gross income was more than \$150,000 (\$75,000 MFS).

Note: The percentage amounts may be different if you are a farmer or fisherman.

Who Does Not Have to Pay Estimated Tax

If you receive salaries and wages, you can avoid having to pay estimated tax by asking your employer to withhold more tax from your earnings. To do this, file a new Form W-4 with your employer. Line 4c on Form W-4 allows you to enter the additional amount you want your employer to withhold.

You do not have to pay estimated tax for the current year if you meet all three of the following conditions.

- You had no tax liability for the prior year,
- You were a U.S. citizen or resident for the whole year, and
- Your prior tax year covered a 12 month period.

You had no tax liability for the prior year if your total tax was zero or you did not have to file an income tax return.

When to Pay Estimated Taxes

For estimated tax purposes, the year is divided into four payment periods. Each period has a specific payment due date. If you do not pay enough tax by the due date of each of the payment periods, you may be charged a penalty even if you are due a refund when you file your income tax return.

2026 Estimated Payment Dates for Individuals

Installment	Tax Period Covered	Due Date
First	January 1 to March 31, 2026	April 15, 2026
Second	April 1 to May 31, 2026	June 16, 2026
Third	June 1 to August 31, 2026	Sept. 15, 2026
Fourth	Sept. 1 to Dec. 31, 2026	Jan. 15, 2027

*Underpayment penalty for fourth installment does not apply if the 2026 return is filed and balance paid by January 31, 2027.

Note: It may be advantageous to pay the fourth period installment of state estimated taxes by December 31, 2026, in order to deduct the amount as an itemized deduction for 2026.

You can use Form 1040-ES, *Estimated Tax for Individuals*, to mail in your quarterly estimated tax payments using a check or money order. You can also make estimated tax payments online at www.irs.gov/payments using a checking/savings account, or debit/credit card (convenience fee applies). Paying online allows you to look up a payment using a confirmation number. You can view your payment history by accessing your online account with the IRS.
